BY THIS AGREEMENT, Tahoe Douglas Fire Protection District Post Retirement Plan & Trust Retiree HRA Plan (herein referred to as the "Plan") is hereby amended as follows, effective as of January 1, 2020:

- 1. ARTICLE III BENEFITS, Section 3.1 Establishment of Plan (c) is amended to read:
 - (c) The Employer shall make available to each Participant an Employer contribution for the reimbursement of Qualifying Medical Expenses. The Employer shall contribute the following monthly amount for all allowable 213 expenses and Medicare Supplemental Insurance Coverage Premiums.
 - (1) \$285 per month per Retiree; or
 - (2) \$570 per month per Retiree and Spouse.

If either the Retiree or the Spouse becomes deceased, then the monthly contribution will be reduced to \$285 per month for the surviving spouse until such spouse becomes deceased. After which claims for qualifying medical expenses must be filed within 90 days.

No Salary reductions may be made to this Retiree Health Reimbursement Arrangement.
